





Even though their Sunday School was small, Ruth realized the need for these children to have an opportunity to both help the Church and learn how to invest for their own future needs. Her husband, Jim, is a church elder and together they kicked off the stamp program for the students this year.

Once stamps were available on Sundays, St. John had several grandparents that became interested in helping their grandchildren get started out on the right foot of stewardship and investing too. "In only a few weeks, the Johnsons had more than \$100 in stamps sold. Not only are the children involved in supporting the ministry of church extension, but so are the grandparents," said LCEF Vice President Bill Sharpe.

LCEF Vice President Dennis Johnson serves the North Wisconsin District and partners with ministries to provide affordable financing and personal service. When Camp Luther's original dormitory facility was filled to capacity, LCEF helped fund a new retreat center with 112 beds on the main floor, 28 guest rooms and four meeting rooms including a chapel. Located just north of Three

Lakes in the beautiful north woods of Wisconsin, this camp is just 90 miles north of Wausau, Wisc. and 130 miles northwest of Green Bay.

The retreat center was a timely addition to the camp in 2001. Following its completion, the program "Every Kid to Camp (EK2C)" increased its enrollment by more than 200 camp-

ers per season. "EK2C was created in response to the district's vision that every child in the North Wisconsin District, LCMS should have the opportunity to attend a week of summer camp. EK2C and Camp Luther are making a difference in the spiritual lives of kids and families throughout the district; for example, in the past three years 430 children (in grades three through eight) who have never had the opportunity to attend Camp Luther before . . . attended free! This year, 250 kids will benefit from free tuition and experience the Christian habits, values, beliefs and attitudes that can strengthen their faith for the future," said Johnson. "Camp ministry is a unique and effective way to help kids continue to grow in their faith and build a strong spiritual foundation. LCEF is proud to partner with this critical ministry."
