## Consecrated stewards at Peace Lutheran Church in Wall Lake look forward

Peace Lutheran Church in Wall Lake recently celebrated its 125th anniversary (1882-2007). "We have had a strong tradition of raising money when there was a need and the congregation would respond positively," said Pastor Roger Carlisle. Over the years Peace devoted significant resources into estate planning and giving. "In 1997, we established an endowment fund which has been a real blessing in accomplishing ministry. For example, each year we



have \$2,000 endowed for congregational youth ministry. However, in recent years, a focused annual stewardship emphasis that included a pledge Sunday was overlooked. The church budget was increasing and each month at the council meeting the focus seemed to turn on paying the bills. At times we had cash flow issues during summer months, even borrowing some money from LCEF to cover operating expenses," said Carlisle.

"In an effort to change this pattern, we pursued Consecrated Stewards and scheduled this emphasis in April of 2008. Rev. Bob Riggert, IDW Executive Assistant for Stewardship, worked with our congregation to that end.

The immediate result of Consecrated Stewards saw a pledged increase of 48 giving units within the congregation for which we give thanks. One of the most significant changes that I witnessed," said Carlisle, "is the change of *thought and language* by the leadership of the congregation." Instead of talking about giving money, leadership began talking about being

'consecrated stewards' as disciples of Jesus. "They kept referencing 'consecrated stewards' when utilizing talents and abilities within the congregation and in all areas of their lives. It changed the mindset of many of our members," continued Carlisle. Throughout the year, Pastor Carlisle witnessed further evidence of spiritual growth and there was no longer a struggle to pay bills. "In fact, at the end of 2008, we ended up with all bills and missions fulfilled, including an outstanding loan, and we were over \$15,000 in the black. A strong farm economy this year was a contributing factor, but without the stewardship emphasis, the church would not have benefited in the same way."

Peace' Board of Elders wanted to maintain the positive momentum and recommended to the council that a celebration and follow up be observed in April, 2009 (one year later). Rev. Riggert will be returning for a two week refresher emphasis.

"The process is well organized and laid out. It does require several members of the congregation to help do the work of this 4 week emphasis "One of the strengths of the program at Peace was their use of the children's component. The children were very involved in



the Consecrated Stewards process," said Rev. Bob Riggert (*above.*)

but it is well worth the effort. While stewardship sermons and messages were constant throughout the years, Consecrated Stewards gives members a handle they can constantly relate to in their own stewardship life," continued Carlisle. "I am looking forward to seeing the Spirit's continued work in the members of Peace as they remain *Consecrated Stewards.*" *Special thanks* to Rev. Roger Carlisle



"The area above the fireside

room entry door is enclosed in glass, which allows us to heat and cool the room without having to use other areas of the building. Plus, the new custom woodwork matches all the existing wood," said Pastor J. David Wende.

Consecration Sunday processes for congregations. He will share a vision of good stewardship with participants, focusing primarily on the <u>treasure</u> aspect.





A fter three consecutive months of declining *total* investment support (Synod-wide,) total investment support <u>grew just over</u> <u>\$11 million in January</u> to \$1,549.3 million. # Lines of Credit and More for LCMS Organizations

for anticipated cash flow deficiencies in their operating budget on a recurring basis. <u>LCEF</u> <u>Lines of Credit</u> offer loan dollars and ministry-focused services to help your church as it

seeks to fulfill God's mission.

LCEF also offers <u>construction and</u> <u>permanent loans</u> to new and existing congregations, schools, recognized service organizations, and partner churches around the world. For your next building project, partner with LCEF. We have loan dollars and ministry-focused services available to help the Church as it seeks to fulfill God's mission.

#### **TYPES OF LOANS:**

•*Secured* (new and refinances.)

•*Specialized Ministry Loans:* The LCEF Loan Committee, in consultation with the district, considers all loan requests. Loans are written at an interest rate of LCEF's cost of funds for a term of five years with monthly payments based upon a maximum 20-year term.

•*Unsecured:* Written in an amount of up to \$100,000 for a term of up to 15 years. A \$350 loan fee will apply for loans of more than \$50,000 and

\$300 for \$50,000 or less.

•*Jump Start:* For the purpose of providing "seed dollars" to support a new ministry program or to expand an existing ministry program, an example could be a staff person for Evangelism Outreach or Dir. of Youth Ministry.

•*Soft Cost:* To provide "working capital" for preconstruction-related costs, e.g., architect/design and engineering fees, market studies, capital pledge campaign expenses, and special assessments. The interest rate charged will be the prevailing rate.
