Preface

“One Message—*Christ!*” served as the theme of the 63rd Regular Convention of The Lutheran Church—Missouri Synod, which convened at the George R. Brown Convention Center in Houston, Texas, July 14–19, 2007. Official attendance included 1,239 voting delegates and more than 400 advisory delegates and other official or invited guests, including partner and sister church leaders from the international Lutheran community who were in Houston for an *Ablaze!* conference.

The convention theme was expanded by the President of the Synod in his sermon during the opening worship service: “One Message—*Christ! His Love Is Here for You!*” It was also the subject of Bible studies led by the vice-presidents of the Synod (“A Message of Love for a Church in Mission”; “A Message of Unity to a Sectarian Culture”; “A Message of Truth to a Post-Modern World”; and “A Message of Love to a Desperate People”), and served as the theme of the memorial service message delivered by Fourth Vice-President Robert King (“One Message: Christ—Resurrection and Life”). Dr. King was given special recognition by the convention for his 21 years of service as a vice-president of the Synod.

In addition to worship and Bible study opportunities, the convention also conducted the business of the Synod, which included the adoption of 76 formal resolutions proposed by convention floor committees and the approval of three omnibus resolutions which referred some convention business to previous convention actions or to various boards and commissions for further attention.

A major action of the convention was the declaration of altar and pulpit fellowship with the American Association of Lutheran Churches. The text of the response to the convention given by AALC Presiding Pastor Thomas Aadland after the action was taken is provided in these *Convention Proceedings*. Other significant business included the creation of a director position for strategic development of Hispanic ministries; the establishment of a Specific Ministry Pastor Program; strong statements regarding stem cell research and the care and placement of foster and adoptive children; the adoption of the bylaw changes to help to resolve Board of Directors/Commission on Constitutional Matters authority issues; and approval for the possible calling of a special convention in 2009 to address Synod structure and governance issues.

All resolutions addressed by the convention are included in their final form in these *Convention Proceedings*, along with the minutes of the ten convention sessions and other related materials. To facilitate reading the resolutions, the following will be helpful:

- An *A* attached to a resolution number indicates that significant changes were made to the resolution by the floor committee after it was published in the first (pre-convention) issue of *Today's Business*. An *S* attached indicates a resolution that the floor committee proposed in place of that which was initially published.
- Following each printed resolution, the decision of the convention is noted. The number in parentheses indicates the convention session in which the final action was taken.
- Comments in parentheses below each resolution provide information regarding changes made or attempted during discussion of the resolution. The vote tally for the final decision is provided in brackets.
- A more detailed record of the discussions and proposed changes of resolutions and all vote tallies during those discussions are provided in the minutes of the convention.

Even as the business of conventions continues long after the closing gavel as decisions are carried out, so also the usefulness of a convention theme is not limited to the few days of convention meetings. How especially true of “One Message—*Christ!*” which will continue to serve our Synod well for the coming three years and far beyond. There is, after all, no other message like “Christ,” for there is “no other name under heaven given to men by which we must be saved” (Acts 4:12).
